Hygiene Controls

Unite against COVID-19


Remember – COVID-19 is still out there. Play it safe.



- Keep your distance from other people to 1 metre
- Wear a face-mask when you are within 1 metre of each other



 Sneeze and cough into your elbow or by covering your mouth and nose with a tissue.





- Wash your hands with soap and water regularly
- Hand sanitiser will be available for your use please don't remove it from shared areas



- Don't touch your eyes, nose or mouth if your hands are not clean
- Additional cleaning of communal areas is in place
- Ensure common work surfaces are regularly disinfected



Wash your hands properly

Follow these steps to wash your hands properly:

- 1. Wet hands with running water
- 2. Apply enough soap to cover wet hands



- 4. Rinse thoroughly with running water
- 5. Dry hands with a clean cloth, single-use towel or blow-drier







Use of Face Masks



- Face-masks are required when personnel are within 1 metre of each other. This does not apply for short moments e.g. when people pass each other walking down a hallway
- See your supervisor for face-masks
- If you are wearing a mask you must be clean shaven
- Wash your hands before donning a face-mask and be careful to only touch the straps when removing, to prevent contact with potential bacteria
- Face masks should be replaced when damp or dirty
- Respect your colleagues choice should they choose to wear a face-mask, outside the 1 metre requirement.

















What to do if you feel unwell







Before travelling to site:

- If you're sick, stay home. Don't go to work
- If you have symptoms at all of cold or flu call your doctor or Healthline and get tested
- Contact your Supervisor



While working onsite:

- If you start to have symptoms of cold or flu e.g. sneezing, cough, runny nose, sore throat ... Stop work, contact your Supervisor and make arrangements to go straight home

Meetings



- Reduce the need to meet in person where ever practical
- The preference for group meetings will be to continue doing these via Skype or Teams
- If you are required to attend a meeting maintain a minimum distance of 1-metre between yourself and others
